Dear Madam/ Sir,

The CCS Haryana Agricultural University, Hisar is going to organize **KRISHI MELA (Kharif)–2020** on **March 22-23 (Sunday & Monday)**. This is one of the most important extension activities of the University for transfer of technology to the potential users/farmers. On this occasion an Agro-Industrial Exhibition will be also organized with a purpose to provide an opportunity to the industrial firms dealing with agriculture and allied fields to display their products to make the visiting farmers aware of the utility of these products. However, sale of products shall not be allowed through the platform of Agro-Industrial Exhibition in **Krishi Mela (Kharif)–2020**.

The CCSHAU **Krishi Mela (Kharif)–2020** attracts large number of farmers not only from Haryana but also from adjoining states like Rajasthan, Uttar Pradesh, Uttrakhand, Punjab, Himachal Pradesh and Delhi. Schematic plan and lot of arrangements are required to be made well in advance. You are, therefore, requested to confirm your participation by providing information in the enclosed Proforma at the earliest so that the arrangements may be made accordingly. The registration charges of stall Indicated below will have to be made **latest by 20 March, 2020** along with the booking Proforma available on University Website and in the O/o Associate Director (Extension) either in Cash or through Demand Draft in favour of **Comptroller, CCSHAU, Hisar**.

1. **REGISTRATION CHARGES per stall (9' x 9')** : Rs. 4000 + GST (@18%) Rs.720 =4720
2. **Open Space of 9' x 9' (OPTIONAL)** : Rs. 1000 + GST (@18%) Rs. 180 =1180

Note: The open space will be provided to only those firms/organizations who are allotted covered stall.

Beside registration fee the participating firm/organization shall have to make payment for the tentage and other related material. The stall will be under the coverage of the Temporary in-built display system of Octonorum infrastructure of ply-board panels under the coverage of the CANOPY made up of MS Tube structure covering top with water-proofing (Tirpal) per stall (Front 9' & Depth 9') including facia duly.

1. **TENTAGE CHARGES per stall : Rs. 7700 + GST 1386 (@ 18%) = 9086/- per stall (In addition to Registration Charges)**
2. **Mode of Payment : Cash or Demand Draft in favour of “Kataria Tent House, Hisar”**
3. **The participating organization will have to pay “Tentage Charges” alongwith registration to get the stall of their choice on First Come First Bases.**
4. **Each stall will be provided 2 chairs, 2 system tables, 1 fan, 1 carpet and two water campers per day(15 liters).**
