AUCTION NOTICE

The fuel wood from lopping, pruning and dead & uprooted trees of different species lying at Forestry Department Research Farm (adjacent to Horticulture department research area; Ludas road) will be disposed off **only through sealed tenders on 04.04.2020 at 3.00 P.M.** The interested persons may please see the fuel-wood before participating in the auction on any working day (9.00 A.M. to 5.00 P.M) and avail the opportunity. The quotation should be reached in the office of Forestry Department **only through speed post/courier/in person up to 03.04.2020 at 4.00 p.m.**

TERMS AND CONDITIONS

1. The bidders will have to attach the earnest money of Rs.4, 000/- in the shape of Demand Draft along with the tender application in favour of Professor and Head, Department of Forestry, CCS HAU, Hisar payable at SBI, HAU Branch, Hisar. The tender application can be obtained from the office of Forestry Department by paying Rs. 100/- only.
2. 25% of the bid value will have to be deposited by highest bidder with the receipt of official orders and the remaining amount will have to be paid before the lifting of fuel-wood, failing which the earnest money will be forfeited. An amount of Rs. 10,000/- (Rs. Ten thousand only) will have to be deposited as security before the start of lifting of material.
3. **The tenders will not be accepted after 03.04.2020 at 4.00 p.m. and the tenders received will be opened next day on 04.04.2020 at 3.00 P.M.**
4. The material should be lifted within 15 days after the auction failing which the material shall be re-auctioned at the risk and cost of the purchaser. However, the Professor & Head, Department of Forestry can extend the time in exceptional cases only.
5. After the auction, the department will not be responsible for loss of material mentioned.
6. The material will be sold "as is where basis is" and the transportation will be made by the purchaser himself.
7. The auction committee reserves the right to accept or reject the highest bid without assigning any reason thereof.
8. The earnest money (Demand Draft) of the unsuccessful bidder will be given back through post after the finalization of the successful bid and no interest will be paid on the same.
9. The security money shall be adjusted/ refunded only after producing the NO DUES CERTIFICATE from the Farm Area In-charge/supervisor of Department.
10. The delivery will be F.O.R. HAU, Hisar on "AS IS WHERE IS BASIS".
11. The department will not be responsible for postal/courier delay of the tender application.
12. In case of any dispute, the decision of the Committee shall be final.
13. All the disputed cases shall be subject to Hisar jurisdiction.
