RE-AUCTION NOTICE

This has reference to this office memo No. Forestry/2020/1639-1700 dated 31.08.2020 vide which the auction of kinnow fruits was fixed for 15.09.2020 at 11.00 A.M. Now the auction will be held on 29.09.2020 at 11.00 A.M. and the sealed tenders will received up to 28.09.2020 up to 2.30 P.M. through speed post/courier/in person and the same will be opened on 29.09.2020 at 11.00 A.M. The other terms and conditions will be same

TERMS & CONDITIONS

1. The bidders will have to attach the earnest money of Rs.4000/- in the shape of demand draft along with the tender application in favour of Professor & Head, Department of Forestry, CCSHAU, Hisar payable at SBI, HAU, Branch, Hisar. The tender application can be obtained from the office of Forestry Department by paying Rs. 100/- only.
2. 25% of the bid value will have to be deposited by highest bidder with the receipt of official orders and the remaining amount will have to be paid before taking over the management of kinnow plants, failing which the earnest money will be forfeited. An amount of Rs. 10,000/- (Ten thousand only) will have to be deposited as security before the start of look after of the plants.
3. The contract will be for two years and all operations costs will be borne by the contractor.
4. The tenders will not be accepted after 28.09.2020 at 2.30 P.M. and the tenders received will be opened next day on 29.09.2020 at 11.00 A.M.
5. After the auction, the department will not be responsible for loss of material mentioned.
6. The kinnow will be sold "as is where basis" all the management practices (insecticides/pesticide spray) will be made by the purchaser himself.
7. The auction committee reserves the right to accept or reject the highest bid without assigning any reason therefore.
8. The earnest money (Demand Draft) of the unsuccessful bidder will be given back through post after the finalization of the successful bid and no interest will be paid on the same.
9. The security money shall be adjusted/refunded only after producing the NO DUES CERTIFICATE from the Farm Area In-charge/supervisor of Department.
10. The delivery will be F.O.R HAU on "AS IS WHERE IS BASIS".
11. The department will not be responsible for postal/courier delay of the tender application.
12. In case of any dispute, the decision of the committee shall be final.
13. All the disputed cases shall be subject to Hisar Jurisdiction.
