TERMS AND CONDITIONS OF AUCTION:-

- 1. The bidder will be required to deposit Rs.20000/- in cash as earnest money/security to the auction committee for participating in the open auction. The security/earnest money of un-successful bidders will be refunded after completion of the auction. The highest bidder will have to deposit the whole amount of the bid value on the same day before 2.00 P.M. The earnest money of the successful bidder will be retained and refunded after completion of the felling and disposal of trees from the farm and no interest will be paid on the same.
- 2. The auctioned trees will have to be uprooted up to 60 cms depth and pits have to be refill with soil. The trees should be lifted within 30 days of auction failing which the remaining material shall be re-auctioned at the risk and cost of successful bidder. However, the Senior coordinator, CCSHAU-KVK, Bhopani, Faridabad can extend the time in exceptional circumstances only.
- 3. Only the numbered trees will be felled and dragging of wood will not be permitted.
- 4. Felling after sunset and before the sun rise will not be permitted and no fire will be allowed.
- 5. After the auction Krishi Vigyan Kendra will not be responsible for loss of any material mentioned in auction.
- 6. It there is any loss of university property including cutting of unauctioned trees by the contractor's men, the contractor will be held responsible and will have to bear the loss.
