IMPORTANT NOTE

Note-1 The posts mentioned in the advertisement at Sr. No. 1 & 2 will be filled on tenurial basis for a period of 4 years only. Those faculty members of CCS HAU who have already served one term as Dean/Director/Registrar/Librarian in this University or any other University will not be considered for the second term. Further those applicants who have less than two years service left on the date of advertisement will also not be eligible for appointment to these posts. Provided further that where a person has already worked as Dean/Director/Registrar/Librarian in the past, that period will be reduced from his/her term of 4 years, if it exceeds 90 days.

Note-II In case any vacancy earmarked for EWS can not be filled up due to non availability of a suitable candidate belonging to EWS, the same will be filled from unreserved category.

Note-III In case no candidate under ESM category is found suitable for appointment, the vacancy reserved for ESM of a particular category will be filled from amongst the same category candidates. Special Instructions

- 1- The applicant must possess prescribed qualifications, age and experience on the last date of **on-line submission** of applications. If on verification, at any time before or after the written examination or interview or appointment, it is found that they do not fulfil any of the eligibility condition or it is found that the information furnished is false or incorrect, their candidature will be cancelled. **However, for the post of Assistant Professor/equivalent the consideration of Ph.D degree will be upto the date of interview subject to submission of thesis as on the last date of receipt of application and production of provisional degree certificate at the time of interview. The publication will also be considered upto the last date of on-line submission and no further addition/correction will be entered through any other mode. The prescribed essential qualification does not entitle a candidate to be called for interview. The University will shortlist 15 eligible candidates against one post and further an addition of five more eligible candidates (i.e. 15+5=20) against each post and so on, as per merit list on the basis of structural marking. Only shortlisted candidates will be called for interview. The condition of shortlisting will also be applicable to the reserved posts.** The decision of the University in all matters relating to acceptance or rejection of an application, eligibility/ suitability of the candidates, mode of and criteria for selection etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.

The candidates are advised to upload the essential qualification certificates/ diploma/degree **showing percentage of marks obtained** with the application form alongwith fresh Eligibility Certificate in case of DESM and Sports, Gradation Certificate in case of eligible Sports Person category and Persons with Disabilities Certificate from the competent authority. The candidates, who have obtained degrees or Diploma or Certificates for the various courses from any institution declared fake by the University Grants Commission and other institutions/agencies, shall not be eligible for being considered for recruitment to the posts advertised.
- 4- Experience for teaching posts will be counted after a candidate has obtained his/her Masters degree. Experience obtained during Ph.D period will not be counted.

- i) A person may be working on an ad hoc basis against the post advertised or somewhere else.

3. A relaxation of 5% may be provided at the graduate and masters level for the SC/ST/Differently-abled (physically and visually differently-abled)/other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic records during direct recruitment to teaching positions. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.

2. Must have passed NET/SLET/SET examination from UGC/CSIR/ICAR/State.

Provided however, that candidates, who are or have been awarded a Ph.D degree in accordance with the University Grants Commission (minimum standards and procedure for award of Ph.D degree) Regulations, 2009 or the subsequent regulations, if notified by the UGC, shall be exempted from the requirement of minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Prof. or equivalent position in Universities/Colleges/Institutions

Further, the award of degree to candidates registered for the M.Phil./Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bylaws/Regulations of the Institutions awarding the degree and the Ph.D candidates shall be exempted from the requirements of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) Ph.D. Degree of the candidate awarded in regular mode only
- b) Evaluation of the Ph.D Thesis by at least two external examiners.
- c) Open Ph.D Viva voce of the candidate had been conducted.

- d) Candidate has published two research papers from his/her Ph.D work out of which at least one must be in a referred journal.
- e) Candidate has made at least two presentations in conferences/seminars, based on his/her Ph.D work.

Condition (a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/Dean (Academic Affairs)/Dean (University instructions).

- 3. A relaxation of 5% may be provided at the graduate and masters level for the SC/ST/Differently-abled (physically and visually differently-abled)/other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic records during direct recruitment to teaching positions. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.

the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.
