Terms and conditions of the tender:-

- EMD should be in the form of DD in the favour of Prof. & Head, Department of Moleculer Biology & Biotechnology, CCS HAU, Hisar. If the work is not executed by the contractor, the EMD will be forfeited and contractor will be debarred.
- 3. Conditional tenders are liable to be rejected.
- 4. The contractor shall be required to sign the contract agreement on bond paper of Rs. 15/- on the prescribed form within ten days of the intimation of the acceptance of tender to him. Failure on his part to do so may result in invalidation of the contract and forfeiture of the earnest money.
- 5. TDS @ 2.00% to be deducted from the bills at source.
- 6. The contractor will have to execute the Job within the given time and no request for extension for time shall be entertained except in unforeseen circumstances.
- Payment will be made after completion of the job satisfactorily on monthly basis.
- 8. The acceptance of the tender will rest with Head, Department of Moleculer Biology & Biotechnolgy who does not bind himself to accept the lowest tender and reserves himself the authority to reject any or all tenders without assigning any reason therefore. All tenders in which the conditions are not fulfilled will be rejected.
- The contractor shall be responsible for observance of the Provisions of the Contract Labour (Regulation and Abolition) Act, 1970. The University shall not be responsible for it in any manner.
- In case of any loss due to negligence of contractual workers, the contractor shall be responsible to make good loss to the HOD, failing which the amount of loss shall be recovered /adjusted from earnest money.
- 11. It will be sole responsibility of the contractor to compensate the labour because of injury, loss of life or limb in accordance with the law in force for the time being. The University will in no way be responsible for such loss.
- 12. It will be the responsibility and liability of the contractor to adhere to the provisions of the ES1 and Provident Fund Act and in case they are not followed properly, he himself will be responsible for it.
- 13. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and the contractor blacklisted. The remaining job shall be got done at the risk and cost of the contractor who has defaulted.
- 14. The university reserves the right of supervision. Transport for transporting labour not be provided by the University.
- The parties may visit the site and contact HOD, Moleculer Biology & Biotechnology, CCS HAU, Hisar for this purpose before submitting their tenders.
- 16. In case of any dispute between the parties, the same will be referred to the arbitration of the Vice-chancellor and his decision shall be final. The provisions of Indian Arbitration Act shall apply to these proceedings.
- The contractor should not use insulting language against any worker.
- 18. The contractor must issue attendance card to each worker employed by him in connection with field operational work so that record pertaining to the attendance of workers should be in the notice of workers.
- 19. As per the provision in the Contract Labour Act, 1970, the contractor shall be responsible for the payment of wages as per D.C. approved rates before expiry of such period as may be prescribed. Any litigation arise due to non-compliance of above conditions will be responsibility of the contractor and settle by him.
- 20. Rates will be accepted only on unit basis.
- 21. It will be sole responsibility of contractor to supply copy of challan regarding PF/ESI.
- 22. The contractor should have at least two year experience of carrying out similar type of field operations in green house and tissue culture lab.

- Workers are paid wages by 7th of every month by contractor.
- Workers are paid the minimum wages at least as provided under minimum Wages Act.
- Wages slip is issued regularly to the workers by the contractors.
- Necessary certificate regarding the above provisions (a to c) be also got recorded in the wages register from Principal Employer or the person who is authorized in this behalf by the Principal employer.
- 24. If the contractor employees 20 or more than this in a particular contract then he should obtain licence from the Labour Department and submit the same to the Principal Employer. Enclose a photocopy of licence along with tender offered. 25. Contractor should obtain license from the Labour Department and submit the same to the Principal Employer.
- 26. The tenders of contractors having PF, ESI code may be accepted in response to tender notice and in case the contractors do not have any code, they should obtain the code from the competent authority.
- 27. Contractors will have to submit a copy of challan regarding PF, ESI to Dept. of Moleculer Biology & Biotechnolgy.
- 28. Due to implementation of GST, all the contractor's are directed to submit their quotation alongwith GST number. Otherwise their quotation will not be entertained.
- 30. The workman deployed through the contractor for field operational work may be paid the minimum wages as per provisions contained under the wages Act and that provisions of working hours may be fixed for them. EPF provisions may also be followed strictly by the contractor. The worker may also be paid minimum wages well in time every month, besides to issue
