**Terms and conditions:**

1. The appointment is co-terminus with the project up to 31/3/2024 or termination of the project, whichever is earlier. However in the case work and conduct is not found satisfactory, his/ her services can be terminated after giving the opportunity. If he/she wants to leave, he/she can do after giving one month notice or one month emoluments in lieu thereof to the university.
2. The services of the SRF will also be liable to terminate at any point of the time without assigning any reason because of non release of grant by funding agency or owing to administrative reason by issue of the one month notice or one month emoluments in lieu thereof.
3. No TA/DA will be given for attending interview.
4. On expiry of the term of the project, he/she will be relieved and the university / department will not responsible for her adjustment in the university.
5. He/she will not be a regular employee of the university and would not be entitled to any CPF/GPF or any other benefit admissible to regular employees.
6. He /she will be required to produce a medical certificate of fitness from the SMO, CCSHAU, Hisar at the time of joining.
7. He /she would report for duty within 15 days from the date of issue of this order failing which per appointment will be treated as withdrawn.
8. The place of work will be the respective KVK and he may be posted at anywhere in interest of university.
9. He/she will be required to execute an agreement on a non- judicial stamped paper of Rs. 15/- before he/she is allowed to join the post.
10. Ph.D candidate has to produce NOC from the Dean, PGS at the time of interview.
11. SRF/JRF will be under the administrative control of P.I. as well as DEE.
12. SRF/JRF will be entitled for leave as per university norms/guidelines issued.



13. SRF/JRF engagement for the scheme will be full time. He will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.


