AUCTION NOTICE

Dead/dried plants of Kinnow (147) and Guava (02) at research farm of Forestry Department will be auctioned through open public auction on 04.04.2025 at 10.00 AM. The interested persons may please see the Dead/dried plants of Kinnow and Guava before participating in the auction on any working day (9.00 A.M. to 4.30 P.M) and avail the opportunity.

TERMS AND CONDITIONS

1. 50% of the bid value will have to be deposited by highest bidder with the receipt of official orders and the remaining amount will have to be paid before the start of cutting, failing which the earnest money will be forfeited.
2. The bidders will have to deposit the earnest money of Rs. 2000 in cash on dated 04.04.2025 at Forestry Research Farm, Department of Forestry, CCSHAU, Hisar before start of bid procedure.
3. The material should be lifted within 07days after the auction failing which the material shall be re-auctioned at the risk and cost of the purchaser. However, the Head Department of Forestry, CCS HAU, Hisar can extend the time in exceptional cases only.
4. The auction material will have to be dug up to 3 ft depth (uprooted) and refilled the pit with soil after uprooting the same. The same will be inspected by the auction committee.
5. After the auction, the University will not be responsible for loss of material mentioned.
6. If there is any loss of University property including cutting of un-auctioned trees by the contractor's labour, the contractor will be held responsible and will have to bear the loss.
7. The material will be sold "as is where basis is" and the transportation will be made by the purchaser himself.
8. The auction committee reserves the right to accept or reject the highest bid without assigning any reason thereof.
9. The earnest money of the unsuccessful bidder will be given back after the finalization of the successful bid and no interest will be paid on the same.
10. The security money shall be refunded only after producing the NO DUES CERTIFICATE from Head Department of Forestry.
11. In case of any dispute, the decision of the Committee shall be final.
12. All the disputed cases shall be subject to Hisar jurisdiction.
13. GST will be applicable on bid amount as per rule, paid by the contractor.
