Grant of interest free Festival Advance to Class IV Government Employees during the year 2025-26

The Vice-Chancellor, CCS HAU, Hisar is pleased to grant an interest free festival advance of Rs.13,000/- (Rupees Thirteen thousand only) to all Class IV University Employees, who apply for it.

- 2. The advance will be admissible to permanent/temporary Class-IV regular State Government employees and will likely to continue in service for another ten months. The advance will be sanctioned by the Drawing & Disbursing Officers concerned. In case of temporary Govt. employees, the festival advance will be admissible on the basis of a surety of a permanent Govt. employee so that it will be fully secured and its recovery will be ensured from the loanee in equal ten installments.
- The following conditions should also be observed in sanctioning this advance:-
 - The Drawing & Disbursing Officer concerned, before sanctioning the advance, i) should satisfy himself that the incumbents will continue in service until full recovery of the total amount of the advance is effected.
 - ii) The advance will be recovered in ten equal monthly installments.
 - iii) The advance may be drawn and disbursed on or before 17.10.2025.
 - The advance will not be admissible to work charged/contingent paid staff/daily iv) wagers and contractual employees.
 - V) The advance should not be granted by parent Departments to those Class-IV State Government employees who are on deputation to other Govt./ Corporations and Local Bodies etc.
 - If both husband and wife are employed, the advance should be allowed to only vi) one of them.
 - No application for the purpose of grant of festival advance shall be entertained vii) and no advance shall be sanctioned/disbursed to Govt. employee who are under suspension or against whom proceedings are pending under Rule 7 of HCS (Punishment and Appeal Rule 2016) as per letter dated 27.09.2021.
 - In case of sanction of festival advance to ineligible employee, the DDO viii) concerned will be responsible and action will be initiated as per rules.
 - In case of misuse of advance, penal interest @ 10% will be charged from ix) concerned employee.

The expenditure may be booked under each respective scheme and recovery be effected for credit to that very scheme as per prescribed procedure.
