Tender forms for filing the tenders can be obtained from the office of the Krishi Vigyan Kendra (Ujha) Panipat on any working day during working hours (9.00AM to 4.00 PM) from 15<sup>th</sup> October 2025 to 29<sup>th</sup> October 2025 and may also be downloaded from the official website of CCS HAU Hisar (http://hau.ac.in) and last date for submission/receipt of duly filled tenders is 29<sup>th</sup> October 2025 upto 4.00 PM with note on the envelope as "Tender Form for Contractual Farm Works (November 2025 to March 2026)" and address to be Sr. COORDINATOR, KRISHI VIGYAN KENDRA, UJHA, PANIPAT-132104. The tenders without earnest money shall be rejected.
- In case tender forms are downloaded from the official website of CCS HAU Hisar, duly filled tender form should be accompanied by a Cross Cheque/Demand Draft of Rs. 100+ 18% GST in favour of Sr. Coordinator KVK Panipat.
- 10. The Administrative Approval to execute the said work has been obtained from the competent authority.
- 11. The tenders shall be opened on 30/10/2025 at 11.30 AM in the office Sr. Coordinator KVK Panipat/Directorate of Extension Education, CCS HAU, Hisar in the presence of tenderers/Rep. who would like to be present at that time. Due to unavoidable circumstances, the date, time and venue for the opening of the tenders may be changed with a notice to this effect on university website.
- 12. The quantity of work given above is tentative and may change depending upon the actual field situation. The contract may be extended through mutual agreement between the parties. The site of

- above-mentioned farm work will be KVK (UJHA) Panipat and the same may be inspected on any working day during office hours.
- 13. The contractor shall be required to sign the contract agreement within 10 days of the intimation of the acceptance of tender to him. Failure on his part to do so may result in invalidation of the contract and forfeiture of the earnest money. Income tax @2% to be deducted from the bill(s) at source.
- 14. The contractor will have to execute the job within the given time and no request for extension of time shall be entertained except in unforeseen circumstances and in the interest of the university.
- 15. Payment will be made after completion of the job satisfactorily or on monthly basis.
- 16. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and contractor will be blacklisted. The remaining job shall be got done at the risk and cost of the contractor who has defaulted.
- 17. The contractor should certify in tender that no other member of his family has applied tender for the same work.
- 18. In case of any dispute between the parties, the same will be referred to Worthy Vice-Chancellor for arbitration and his decision shall be final. The provision of Indian Arbitration Act shall apply to these proceedings.
- 19. The committee shall have the right to open negotiations without assigning any reason. The committee further reserves the right to accept or reject the lowest tender without assigning any reason.
- 20. Only registered labour contractor will be eligible for the allotment/ assignment of the job contract as per existing norms of the University.
- 21. It will be the responsibility of the contractor to make the payment to the labour upto 7th of each month.
