- 2. Tenders for the job on contract work will be opened on the 19.11.2025 at 11.00 a.m. in the presence of Committee at KVK Pandu Pindara, Jind. In case of holiday or in case of non availability of committee members tenders will be open next day or other working day after discussion to members. Members and tenderers or their agents who may like to present.
- 3. Tenders must be sent by post (complete in all documents) in a sealed envelope by due date or be delivered in person by the tenderers or their agents to KVK, Pandu Pindara, Jind. On the envelop tender's address be also given as from (with name and address of the quote) on the other side of the envelope.
- 4. Earnest money must accompany each tender in the shape of Cheque/cash/draft in F/o Chief Scientist cum Head, KVK Jind of any schedule bank at Jind and each tender is to be sent in a sealed cover super scribed:- "Tender for Job work of Farm operation"
- 5. Tenders not accompanied with earnest money in the shape as described above of any schedule bank shall not be considered. In case of non-acceptance of the tenders, the amount shall be refunded to them on the same day.
- 6. The contractor shall be required to sign the contract agreement on the bond paper on the prescribed form within 10 days of the intimation of the acceptance of tender to him. Failure on his part to do so may result in invalidation of the contract and forfeiture of the earnest money.
- 7. It is further ensured that the necessary affidavit will be obtained from the contractor that he will not be incumbent to complete 240 days.
- 8. Income tax @ 2% to be deducted from the bill(s) at source.
- 9. The contractor will have to execute the job within the given time and no request for extension or time shall be entertained except in unforeseen circumstances.
- 10. Payment will be made after completion of the job satisfactorily.
- 11. The contractor shall be responsible for observance of the provision of the contract labour (regulation and Abolition) Act, 1970. The University shall not be responsible for it in any manner.
- 12. In case of any loss due to negligence of contractual workers, the contractor shall be responsible to make good loss to the, failing which the amount of loss shall be recovered/adjusted from earnest money. Contractor will be liable to pay an appropriate fine as assessed if work is not completed/ delayed.
- 13. It will be whole responsibility of the contractor to compensate the labour on account of injury, loss of life or limb in accordance with the law in force for the time being. The University will in no way be responsible for such loss.
- 14. The contractor shall be required to provide small agricultural implements (hand tools) *i.e.kassi, kasola* and *drati* etc. he will have to work as per the instructions given by the Farm In-charge, Scientist concerned/ TA (Farm) at the site. Contractor will maintain daily labour record and provide the services as per requirement. No payment will be made without daily record signed by TA farm, area in-charge and Sr. Coordinator.
- 15. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and contractor blacklisted. The remaining job shall be got done at the risk and cost of the contractor who has defaulted.
- 16. The KVK reserves the right of supervision. Transport for transporting labour will not be provided by the KVK.
- 17. The parties may visit the site i.e., CCS HAU KVK, Pandu Pindara, Jind, for this purpose before submitting their tenders.
- 18. In case of any dispute between the parties the same will be referred to arbitration of the Vice Chancellor and his decision shall be final.
- 19. The instruction issued vides Registrar's Endst. No. 6653-6775 dated 04.07.2015 shall be followed.
- 20. It will be the responsibility of the contractor to make the payment to the labour upto 7<sup>th</sup> of each month.
- 21. Workers are paid the minimum wages at least as provided under the minimum wages act.
- 22. Wages slips are issued regularly to the workers by the contractors.
