LIFE TIME ACHIEVEMENT AWARD

1. Name of the Award.

Chaudhary Charan Singh Haryana Agricultural University Life Time Achievement Award (HAULTA Award)

2. Nature of Award.

CCS HAU, Life Time Achievement Award shall be Biennial.

3. Eligibility.

A person who has served CCSHAU in any capacity should generally meet maximum, but not limited to the criteria mentioned under objectives and should be above 60 years of age on 31st of December of the second year of the biennium of the award.

4. Procedure.

1. The Member Secretary will invite nominations two months prior to ending (i.e. 31st December) of a particular biennium and the result will be finalized by 28th Feb. of the next calendar year i.e. two months after ending of the biennium.
2. No supplement information will be entertained.

6. Description

1. The Award consists of a Plaque of honour, citation and cash prize of Rs. 1.00 lac.
2. Travel expenses for attending the award ceremony will be borne by the university.
3. In the event of death of the person after announcement, the award will be given posthumously. A deceased person will also be considered for the award.
4. Nomination of an awardee will not be considered again.

7. Application & Nomination.

1. Candidates should apply in given proforma and get application recommended by any one of the Ex-Vice-Chancellors, Ex-Deans and Directors of CCSHAU or the awardees of HAULTA Award.
2. Nomination for the award can also be made by the Ex-Vice-Chancellors, Ex- Deans and Directors of HAU as well as the awardees of HAULTA Award for any candidate with due recommendation.
3. Nominations for deceased persons can also be done by Ex-Vice-Chancellors, Ex-Deans and Directors of HAU as well as the awardees of HAULTA Award.
4. Nomination/Application must be accompanied by brief bio-data.
5. Nominations/candidature shall be valid for one biennium only.

8. Process

1. The selection committee shall carefully examine the information provided by the nominators. Selection will be made by consensus. In case of divergent views of the members, the expert opinion can be obtained from person(s) so appointed by the Vice-Chancellor.
2. The deliberation relating to selection will be confidential and decision of the committee shall be final.
