CCS HAU College of Agriculture, Bawal (Rewari) invites sealed tenders for hiring the services of medical doctor with requisite qualification on contractual basis with the terms and conditions as notified by CCS HAU, Hisar from time to time and for the time being in force.

1. Name and address of the Deptt.: CCS HAU, COA, Bawal (Bawal Campus)
2. Job description and other related activities/operations in details: Services of medical doctor
3. Duration of the contract: 01.04.2026 to 31.03.2027
4. Date of opening of tender: 25.02.2026 **at 10 A.M.**

**Terms and conditions of the tender:**

1. The Doctor must be MBBS and registered with SMC/MCI. Attach Proof
2. The hospital of the doctor should not be more than 5 KM away from CCS HAU, Bawal
3. The hospital/doctor will provide free ambulance services to the students and staff from hostel/campus to his hospital in case of emergencies
4. The doctor will make 3 visits each of 2 hrs during a week on alternate days. The timings will be decided keeping in view the convenience of students and staff of CCS HAU Bawal Campus.
5. The doctor will provide nursing staff from 9 AM to 4.30 PM daily for first aid and providing medicine as prescribed by the doctor
6. The doctor will not charge OPD/consultancy charges if any from student/staff members of CCS HAU Bawal visit the hospital for checkup/consultancy
7. Preference will be given to hospital/doctor who can arrange the visit of a lady doctor at least once a week.
8. Tender will receive by the office of Principal CCS HAU COA Bawal up to 4.30 PM on 24.02.2026 and will be opened by committee on 25.02.2026 at 10.00 AM in the presence of such tenders or their agents who may like to present.
9. Tenderer should also deposit Rs. 100/-+18% GST in the O/o Principal as tender fee with tender.
10. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and contractor will be black listed. The remaining job shall be done at the risk and the cost of the contractor who has defaulted.
11. The parties may visit and contract Principal, COA, Bawal for this purpose before submitting their tender.
12. In case of any dispute between the parties the same will be referred to arbitration of the Vice-Chancellor and his decision will be final.
13. The committee shall have the right to open negotiations without assigning any reason. The committee further reserves the right to accept or reject the lowest tender without assigning any reason.
14. No other member of the contractor family should quote rates for this work.
