Subject: Regarding examination of 2nd semester 2019-20.

1. This is in continuation to this office Memo No.PGS/A6/20/6805-59 dated 22.7.2019 regarding examination of 2nd Sem. 2019-20. The online examination of the following PGS courses(Non credit) for M.Sc. final year students has been fixed as per below schedule:

The time of examination will be fixed by the concerned instructors. The HODSs must ensure that requests of all the final year M.Sc. students who could not clear these courses should sent to the concerned instructors on or before 30.7.2020.

2. Further, as per Registrar's instructions issued vide Memo No.Acad/20/A4/16409-18 dated 9.7.2020, the M.Sc. students who are not satisfied with result of 2nd semester 2019-20 on the basis of calculations can opt for appear in the usual offline examination as and when university re-open and resumes its normal operations.

3. In light of above instructions , the results of M.Sc. final year students has been declared and the semester reports of the students have already sent to the concerned HODs . For those students of M.Sc. final year who are not satisfied with the results already declared on the basis of calculation the following procedure is to be followed:

- i. Such students can appear in the final examinations of all registered courses of 2nd Sem. 2019-20.
- ii. For this they will submit their requests to the concerned Dean of the College through HOD upto 06.08.2020 for fixing of their examinations.

- iii. Consequently the concerned Dean will send their coursewise complied details to the office of Dean, PGS for finalisation of schedule of examination, to be conducted at College level.
