

## ORDER

Since Corona positive cases have been reported within District from the area of **Uklana Mandi, Hisar** & hence area between [Point A- **Sharma Namkeen Bhandar**, Point B- **Omparkash Kiryana**, Point C- **Sadhuram / Satish Kumar Trading Company** and Point D- **Agrasen Park in Uklana Mandi**] are declared as **Containment Zone** and **Pooja Soni Aangan wadi area (Old Anaj Mandi, surrounding Sanatan Dharam mandir aera)** is declared as **Buffer Zone** for all the purposes and objective as prescribed in the protocol of COVID-19 District Containment Plan (Health Department) to prevent its spread in the adjoining areas.

For combating the situation at hand, the following action plan is prescribed to carry out screening of the suspects, testing of all suspected cases, quarantine, isolation, social distancing and other public health measures in the Containment Zone as well as Buffer Zone effectively:

1. At-least **one teams** comprising of Asha Workers and ANMS for conducting door to door screening/thermal scanning of each and every persons of the entire households falling in the Containment Zone shall be deployed by the Civil Surgeon Hisar and for these teams there would be **one supervisors** doctor for supervision & reporting. All of them would work under the strict directions of the Civil Surgeon, Hisar. All the staff on duty shall be provided with personal protective equipments and other required devices for screening/thermal scanning etc. Gates/Door Knobs of each and every household will be properly sanitized.
2. The entire areas of Containment Zone and Buffer Zone will be fully sanitized by the **Civil Surgeon, Hisar**. It shall be ensured by the Civil Surgeon, Hisar that the staff deployed for complete sanitization of the locality is adequately provided with personal protective equipments viz. face masks, gloves, caps, sanitizers, shoes and also follow social distancing norms. No sweeping of the area shall be done rather the solid waste shall be picked/lifted properly to avoid dust.
3. Movement of inhabitants of Containment Zone shall be absolutely restricted and the entire Containment Zone shall be sealed by deployment of adequate police force and setting up of required number of Nakas etc. by the **Superintendent of Police, Hisar**. The perimeter control will ensure that there is no unchecked outward movement of population from the containment zone except for maintaining essential services. Thermal screening, IEC shall be carried out at all entry and exit points. All vehicular movement, movement of public transport and personnel movement will be stopped in containment zone and all roads including rural connecting the containment zone will be guarded by the police. For personnel and vehicles requiring movement, a pass/ID card may be issued with details recorded and communicated by **SDO (C), Barwala**. The Containment will be for twenty eight days.
4. SDO (C). will also post signs and create awareness informing public about the perimeter control of the containment zone. Health workers posted at the exit point will perform screening (e.g. interview travelers, measure temperature, record the place and duration of intended visit and keep complete record of intended place of stay). Details of all persons moving out of perimeter zone for essential/ emergency services will be recorded and they will be followed up through IDSP. All vehicles moving out of the perimeter control will be decontaminated with sodium hypochlorite (1%) solution.
5. That in the buffer zone no perimeter control will be observed and all commercial activities will be continued as in other normal area.
6. Necessary barricading of the Containment as well as Buffer Zone shall be done by the Superintendent Engineer, PWD (B&R), Hisar in consultation with the Police Authorities.
7. **Sh. Arjun Dev, PGT, GSSS, Uklana Mandi (94162-40479)** is hereby appointed as Duty Magistrates for the Containment Zone and Buffer Zone for maintenance of law and order and to ensure supply of essential goods and effective enforcement of the perimeter control & implementation of all instruction/guidelines of the containment zone.



8. **Sh. Ankush Goyal, SDO, Irrigation Department Const. Div-6 Hisar (99922-26181)** will be the incident commander in the containment zone and he will address the grievance of the public in the containment zone in consultation with SDO(c) and other services providers/ departments.
9. Civil Surgeon will provide PPE Kits and N-95 and Tripal Laya masks to the duty magistrate in the containment zone as per requirement.
10. Sufficient stock of personal protective equipments/devices and required medicines shall be kept at the control room by the Civil Surgeon Hisar.
11. **All house in containment zone** will be medical facilities for active and passive surveillance in containment zone. Whereas **All Medical Store/ Hospital in vicinity** will be passive surveillance facilities in buffer Zone **CHC Uklana** will be medical facilities in the containment zone & **MAMC Agroha** will be Covid Hospital.
12. General Manager, Haryana Roadways, Hisar shall deploy two buses exclusively for carrying the Asha Workers/ANMs from Hospital to the Zones and drop them back as per the requirement of the Civil Surgeon.
13. Demand of essential goods/commodities such as raw ration/milk/grocery/ medicine/ vegetables shall be worked out and lists shall be prepared by the DMEO, DFSC and Drug Control Officer, Hisar. There shall be separate packets of vegetables, ration/grocery items, milk etc. and delivery of the same would be ensured at the door step. The delivery boy would wear personal protective equipments and drop the packets at the door itself. He will not go inside of any house or make physical contact with any person.
14. The grocery items, milk, vegetables, medicine/personal protective items etc. shall be made available according to the demand, by the DFSC, Hisar, GM Milk Plant, DMEO, HSAMB, DCO and Civil Surgeon, Hisar respectively and all these items shall be kept at **Tehsil Office Uklana** in sufficient quantity under the supervision the **Naib Tehsildar Uklana**.
15. Regular power supply in the Containment/Buffer Zone shall be ensured by SE, DHBVN, Hisar.
16. Regular safe drinking water supply shall be ensured by the SE Public Health, Hisar.
17. Ambulances and other para medical staff shall be deployed by the Civil Surgeon, Hisar as per requirement.
18. **SP, Hisar** will ensure proper deployment of police force in the Containment and Buffer Zone as per the requirement and protocol.
19. **SDO(C), Barwala** will ensure that flex board bearing no of the duty magistrate, incident commander & other essential services are installed at the main entrance of containment zone.

The **Sub Divisional Magistrate, Barwala (94660-92845)** shall be the Overall Incharge of the Containment/Buffer Zone. He will ensure delivery of all essential items at the door step through officers of concerned departments and oversee all the arrangements.

All the officers/officials on duty shall perform/discharge their duties efficiently and any laxity on the part of any officer/official will attract strict action under the Section 56 of the Disaster Management Act, 2005.


