Sub: Revision of pension/Family pension of pre 01.01.2016 pensioners/family pensioners of CCSHAU, Hisar w.e.f. 1.1.2016.

Please refer to this office Memo No. CAUH./P.6/2018/3639-3800 dated 09.02.2018 and memo No. 7347-465 dated 22.03.2018 vide which it was requested to fill up the Annexure 2 (for pensioner) and Annexure-3 (for family pensioner) and get it verified from the audit and send to this office for re-fixation of pension.

2. In this connection It is intimated that the Joint Director (Audit) pointed out that AG Haryana has raised some queries and the matter was still under consideration of the Finance Department. Further, it is brought to your notice that the Haryana Govt. has clarified the position to the A.G. Haryana vide its Memo No. 2/23/2016-1 Pension (FD) dated 12.04.2018. As pointed out in Annexure-1 of letter dated 10.01.2018 of Sr. No.14 reproduced as under for calculation of revised pension may be made as per Rules & conditions as applicable at the time of retirement i.e. "Revised pension w.e.f. 1.1.2016 as per first formulation (Amount: of pension has been reduced pro-rata according to length of service as prescribed in the rules and calculation has also been made on the basis of average emoluments of last ten months or last pay drawn (as the case may be)."

Consequently A.G. Haryana vide its letter No. Pen.-I/Hosting of Website/229-30 dated 23.04.2018 has requested all the pension sanctioning authority to process the cases & finalize the revised pension to the pensioners/family pensioners. The audit has agreed that the notional pay and pension would be proposed in Annexure-2 (for pensioner) & Annexure-3 (for family pensioner) by the concerned DDO/HOD and sent the cases to this office with service book of the pensioners/family pensioners. After countersignature from CAU, this will be verified by the J.D. (Audit).

The HODs /DDOs are requested to take action accordingly.
