Extension of benefits of 'Retirement Gratuity and Death Gratuity' to the Haryana Government employees covered by New Defined Contributory Pension Scheme (known as NPS).

I am directed to refer to the State Government's Office Memorandum No. 2/6/2010-1Pension dated 19.01.2017 vide which the benefit of 'Retirement Gratuity and Death Gratuity' has been extended to the Haryana Government employees covered under New Defined Contributory Pension Scheme (known as NPS) w.e.f. 01.01.2006, on the same terms and conditions, as are applicable to Government employees covered under CSR Vol. II.

These orders are applicable to those Haryana Government employees who joined Government Service on or after 01.01.2006 and are covered by New Defined Contribution Pension Scheme (known as NPS).

A number of queries have been received from the quarters concerned for grant of benefit of Service gratuity under New Defined Contributory Pension Scheme (known as **NPS**).

After due consideration, as per decision of Government of India, it is clarified that Service Gratuity is admissible to only those Government employees who are covered by the defined benefit pension scheme but are not eligible to monthly pension under that scheme on account of qualifying service of less than 10 years. However, Service Gratuity is not admissible to those Haryana Government employees who are covered under the New Defined Contributory Pension Scheme (known as NPS).
