Since Corona positive cases have been reported within following areas of District Hisar for all the purposes and objective as prescribed in the protocol of COVID-19 District Containment Plan (Health Department) to prevent its spread in the adjoining areas.

For combating the situation at hand, the following action plan is prescribed to carry out screening of the suspects, testing of all suspected cases, quarantine, isolation, social distancing and other public health measures in the Containment Zone as well as Buffer Zone effectively:

- 1. At-least one teams comprising of Asha Workers and ANMS for conducting door to door screening/thermal scanning of each and every persons of the entire households falling in the one supervisors doctor for supervision & reporting. All of them would work under the strict protective equipments and other required devices for screening/thermal scanning etc. Gates/Door knobs of each and every household will be properly sanitized.
- 2. The entire areas of Containment Zone and Buffer Zone will be fully sanitized by the Civil Surgeon, Hisar. It shall be ensured by the Civil Surgeon, Hisar that the staff deployed for complete masks, gloves, caps, sanitizers, shoes and also follow social distancing norms. No sweeping of the area shall be done rather the solid waste shall be picked/lifted properly to avoid dust.
- 3. Movement of inhabitants of Containment Zone shall be absolutely restricted and the entire required number of Nakas etc. by the Superintendent of Police, Hisar/hansi. The perimeter Containment zone except for maintaining essential services. Thermal screening, IEC shall be carried out at all entry and exit points. All vehicular movement, movement of public transport and the Containment zone will be guarded by the police. For personnel and vehicles requiring

- movement, a pass/ID card may be issued with details recorded and communicated by **concerned SDO (C).** The Containment Zone will be for twenty eight days and time period of containment zone will be complete on 30-08-2020.
- 4. SDO (C), concerned will also post signs and create awareness informing public about the perimeter control of the Containment zone. Health workers posted at the exit point will perform screening (e.g. interview travelers, measure temperature, record the place and duration of intended visit and keep complete record of intended place of stay). Details of all persons moving out of perimeter zone for essential/ emergency services will be recorded and they will be followed up sodium hypochlorite (1%) solution.
- 5. That in the buffer zone no perimeter control will be observed and all commercial activities will be continued as in other normal area.
- Necessary barricading of the Containment as well as Buffer Zone shall be done by the Municipal Corporation, Hisar in consultation with the Police Authorities.
- 7. Following officers are hereby appointed as Duty Magistrates for the Containment Zone and Buffer Zone for maintenance of law and order and to ensure supply of essential goods and effective enforcement of the parimeter control & implementation of all instruction/ guidelines of the containment zone. The incident commander in the Containment zone and he will address the grievance of the public in the Containment zone in consultation with SDO(c) concerned and other services providers/ departments:-

- 15. Regular safe drinking water supply shall be ensured by the SE Public Health, Hisar.
- 16. Ambulances and other para medical staff shall be deployed by the Civil Surgeon, Hisar as per
- 17. SP, Hisar/Hansi will ensure proper deployment of police force in the Containment and Buffer
- 18. SDO(C), concerned will ensure that flex board bearing mobile no. of the duty magistrate, incident commander & other essential services are installed at the main entrance of Containment zone.

Concerned Sub Divisional Magistrate, shall be the Overall Incharge of the Containment Zone and Buffer Zone falling their juridiction. He will ensure delivery of all essential items at the door step through officers of concerned departments and oversee all the arrangements.

All the officers/officials on duty shall perform/discharge their duties efficiently and any laxity on the part of any officer/official will attract strict action under the Section 56 of the Disaster Management Act, 2005.
