ORDER

In compliance of the direction issued by the National Disaster Management Authority (NDMA) under Section 62 (1) of the Disaster Management Act, 2005 and further to implement these directions, guidelines have been issued by the Union Home Secretary, Government of India vide No. 40-3/2020-DM-1(A) dated 24 March, 2020 and further modified till date, to the State/UT Governments for strict Implementation and Standard Operating Procedure (SOP) for movement of stranded worker by train issued by National Executive Committee.

The Standard Operating Protocol (SOP) issued by Home Secretary vide letter dated 19-05-2020 is reiterated here in order to facilitate movement of stranded workers by trains, the following SOP is hereby laid down:

Standard Operating Protocol (SOP) for movement of stranded workers by train

Due to lockdown migrant workers are stranded at different places. They would be allowed to move by trains as under:

- i. Movement of Shramik Special trains shall be permitted by Ministry of Railways (MOR), in consultation with Ministry of Home Affairs (MHA).
- All States/ UTs should designate nodal authorities and make necessary arrangements ii. for resolving and sending such stranded persons.
- The train schedule including stoppages and destination shall be finalized by MoR iii. based on the requirements of States/UTs and shall be communicated by MOR to the States/ UTs for making suitable arrangements for sending and receiving such stranded workers.
- Train schedule; protocols for entry and movement of passengers, services to be iv. provided in coaches, and arrangements with States/ UTs for booking of tickets shall be publicized by MoR.
- Sending States/ UTs and MoR shall ensure that all passengers shall be compulsorily v. screened, and only asymptomatic passengers are allowed to board the train.
- During boarding and travel, all passengers will have to observe social distancing. vi.
- On arrival at their destination, the traveling passengers will have to adhere to such vii. health protocols as are prescribed by the destination State/UT.
