

Information under RTI Act 2005 Rule 4 (I) :-

- (i) Agricultural Technology Information Centre (ATIC) popularly known as Kisan Sewa Kendra, is situated near Gate No. 4, CCS HAU Hisar (Haryana) -125004. Its objective is to provide a 'Single Window' delivery system for the products available from an institution to the farmers. Seeds of different field crops (Rabi and Kharif), non-seed items, planting materials, university publications and value added products like (squash, aonla, etc.) are sold to the farmers and other interested persons. Technological advices related to cultivation of crops are provided to the farmers through Toll free helpline no. 18001803001 on Monday, Wednesday and Friday from 10.00am to 12.00noon.
- (ii) To Guide the Farmers visiting at ATIC through Toll Free Helpline no. 18001803001 on Monday, Wednesday & Friday (10am to 12Noon).
- (iii) The decisions of CCS HAU, Hisar are implemented. Manager also makes its decision at local level in consultations with the faculties.
- (iv) Farmers are guided through Toll free helpline no. for solution of problems related to cultivation of crops. Seeds of different crops (Rabi & Kharif) and value added products are sold through single window delivery system.
- (v) This Kendra works as per CCS HAU, Hisar guidelines. Rules and regulation, instructions, manuals are available on the webpage of the university.
- (vi) All unclassified documents for sales of seed and record of its staff are maintained by ATIC.
- (vii) It receives the orders from CCS HAU Hisar and from ICAR ATARI-Jodhpur.
- (viii) Problems of the farmers are resolved at the spot or send to the concerned department on the need basis.
